

# **NOMTASTICAPPS, LLC PRIVACY POLICY FOR APPS**

This privacy policy governs your use of all software applications developed by **NOMTASTICAPPS, LLC** (“Applications”).

## **What Information Do the Applications Obtain and How Is It Used?**

### **User Provided Information**

## **Do Third Parties See and/or Have Access to Information Obtained by the Applications?**

We may share User Provided Information and Automatically Collected Information with third parties under various circumstances, including, but not limited to:

- **Service Improvement and Analytics:** Information may be shared with external services, partners, or providers for purposes such as analytics, advertising, and to improve functionality.
- **Legal Compliance:** We may share your information as required by law, such as in response to a subpoena or other legal processes.
- **Business Transfers:** In the event of a merger, acquisition, or sale of assets, your information may be transferred as part of that transaction without further notice.

## **AI Processing and Data Storage**

We may retain User Provided Information and Automatically Collected Information as long as necessary to fulfill the purposes for which it was collected, or as required by applicable laws.

## **Data Anonymization and Aggregation**

## **HealthKit Integration**

Where applicable, the Applications may integrate with Apple's HealthKit to track and store health-related information on your device. Health data will not be shared with third parties unless necessary for core functionality.

## **Children's Privacy**

The Applications are not intended to knowingly collect information from children under 13. If we become aware that we have collected such information, we will delete it without notice.

## **Security**

We take reasonable measures to protect your information. However, no system can be completely secure, and we do not guarantee the absolute security of your data.

## **International Data Transfers**

Your data may be transferred to, processed, or stored in locations outside of your country of residence. By using the Applications, you consent to such transfers and acknowledge that your data may be subject to the laws of those jurisdictions.

## **Limitation of Liability**
